Alan has heard, almost a year after the "indulto particular", appeal for forgiveness, was entered on his behalf, that it had not been granted. The indulto was backed with a letter from his brother Norman Jones, of Leslie Street, Porth, to the

They had hoped he would be home last Christmas, then that it would be in the spring.

The news that Alan would not be home this year has upset his parents, Mr. and Mrs. Jim Jones, of Wyndham Street, Pentre. "I was really distressed," Mrs. Jones said.
"I had really set my heart on it that he was coming home any time. We went out and bought a new bed last year and his room is ready for

In a recent letter home Alan says he has got over this disappointment and is hopeful of being home in eight months.

Since being transferred to a prison in Madrid, Alan has been working on the psychiatric wing of the prison hospital. Although he is on call 24 hours a day, he has a room of his own and his conditions are better than they have been for a long time.

Alan was arrested in July, 1978 in Cueuta, Spanish Morocco, and charged with smuggling 601bs, of hasish over the border. If was a year before he was tried and found guilty although he has always protested his inhocence saying the drugs were planted

Alan's case was taken up by the National Council for the Welfare of Prisoners Abroad which was founded to provide a welfare service and to act as a "voice" for people in prison OVERSEAS.

The Council are campaigning for transfer treaties between British and other coutries, but because there is no provision in British law for them they have to persuade government to change legislation before the business of making treaties can begin.

Spanish Jobs schem plea fails abused—sa

A BLEAK PICTURE of the way the Youth Oppo Programme is working in the Rhondda was painted in a BBC 2's Newsnight programme this week.

An investigation hands - free of charge, showed how in some cases the scheme offers the employers the oppeople. But the careers adviser for Rhondda feels the programme was unfair.

A garage owner admitted he down for the scheme. had 'employed' a stream of YOP youngsters over the past few years - while at the same time he had reduced his staff from 21 to seven.

Also in the programme, the proprietor of a hairdressing salon admitted to offering places to one youngster after another without there being any chance of them being offered a proper apprenticeship.

because youngsters employed under the scheme are paid from Government money.

And at the same time, in the portunities not young case of the garage, the scheme is actually poaching full time jobs and putting people out of work.

At the moment there are more than 600 youngsters (between 16 and 19) in the Rhondda employed on a YOP scheme. There are 788 youngsters (between 16 and 19) out of work altogether.
